HORSE TRAILER RENTAL RELEASE, ASSUMPTION OF RISK AND HOLD-HARMLESS AGREEMENT

PLEASE READ CAREFULLY BEFORE SIGNING — THIS IS A RELEASE OF LEGAL RIGHTS.

The undersigned ("Undersigned") assumes the unavoidable risks inherent in all horse-related hauling, including but not limited to bodily injury, death, and physical harm to horse, driver, rider, and spectator.

In consideration for the privilege of renting and using the horse trailer owned by **Little Bird Stables, LLC** (the "Stable"), a California limited liability company, located at 26441 Houston Trail, Laguna Hills, CA 92653, the Undersigned agrees to hold harmless and indemnify the Stable, its members, managers, staff, and agents, and to release them and their heirs and assigns from any liability or responsibility for accident, damage, injury, or death to the Undersigned or to any horse owned or used by the Undersigned, or to any family member or spectator accompanying the Undersigned.

The Undersigned agrees to abide by all rules of the road, to use exceptional caution and slow speed, and to be financially responsible for any damage to the trailer. The Undersigned expressly assumes responsibility for all risks arising from use of the Stable's trailer.

Risks inherent in equine activities. The Undersigned understands there are inherent risks in and around equine, meaning dangers or conditions integral to equine activities, including: (i) the propensity of a horse to behave in ways that may cause injury, harm, or death — including bucking, biting, bolting, kicking, rearing, spooking, throwing the rider, falling, or stepping on the rider; (ii) the unpredictability of a horse's reaction to medication, injuries, sounds, sudden movements, unfamiliar objects, persons, or other animals, and to surface and subsurface ground conditions; (iii) collisions with other horses or objects; and (iv) the inability of another participant to control their horse. There are also risks of the road, including accidents that could result in injury or death to horse or human.

The Undersigned is responsible for full and complete insurance coverage. The Stable is not responsible for injuries, medical expenses, or for lost, damaged, chewed, or stolen personal belongings.

Release of known and unknown claims. In consideration of this rental, the Undersigned — for the Undersigned and on behalf of any driver, immediate family, heirs, legal wards, administrators, personal representatives, and assigns — agrees to hold harmless, release, and discharge the Stable from all claims, demands, causes of action, and legal liability, whether known or unknown, and shall not bring any claim or action against the Stable for any economic or non-economic loss due to bodily

injury, death, or property damage sustained by the Undersigned or anyone accompanying the Undersigned in relation to the hauling of a horse.

Civil Code §1542 waiver. The Undersigned waives the protection of any statute or law in any jurisdiction (including California Civil Code section 1542) whose effect is that a general release does not extend to claims the releasing party does not know or suspect to exist at the time of signing.

The Undersigned has read the above, understands and agrees to each section, and understands that if any provision is deemed unenforceable, the remainder of this Agreement survives with that provision removed.
